## CARE INSTRUCTIONS FOR PRODUCTS

## HOW TO HAND WASH YOUR PRODUCTS

- 1. **Separate by Color**: Always wash light and dark items separately to prevent color transfer.
- 2. **Prepare a Wash Basin**: Fill a large bowl or your sink with cool water.
- 3. Add Gentle Cleanser: Use a few drops of laundry detergent.
- 4. **Wash Thoroughly**: Gently scrub with your hands, focusing on any stained areas.
- 5. Rinse Well: Rinse until all detergent is completely removed.
- 6. **Dry with Care**: Hang in a well-ventilated area.

## HOW TO MACHINE WASH YOUR PRODUCTS

**Note**: We do not recommend machine washing rayon, linen, wool or silk. If you are unsure what material your product is made out of, check the product page for details or send us an email!

- 1. **Select a Gentle Cycle**: Use the delicate or hand wash cycle with warm or cold water.
- 2. **Minimize Spin**: Choose the lowest spin speed to prevent stretching or wear.
- 3. **Air Dry**: Always hang or lay flat to dry, as heat can damage delicate materials.

## **CARE TIPS FOR LONGEVITY**

- **Storage**: Store your clothing folded neatly in a drawer to maintain their shape.
- Avoid Heat: Never expose your product to direct heat from dryers or irons. Turn on reverse side to iron. Do not directly iron designs.
